Jeana reported that we have currently spent \$88,529.20 for Zoning since its inception. March Bills from 2/10 to 3/10 presented and Chris moved to approve, Karen supported. Roll call vote: Karen Miller - yes, Jeana Rohrs - yes, Steve Davidson - yes. Chris - yes, Roger Wickerham -yes, Motion carried 5 ayes; 0 nays.

March 31- May 12th Bills were presented: Karen moved to approve and Steve seconded. <u>Roll call vote: Karen Miller - yes, Jeana Rohrs - yes, Steve Davidson - yes. Chris - yes, Roger Wickerham - yes, Motion carried 5 ayes; 0 nays</u>

<u>Clerk's Report</u> – The clerk's report was included in the packet. There were 10 people who filed to run for 7 offices on the August ballot. There have been 287 ballot applications mailed for the August election. 252 Ballot Applications have been returned for the November ballot. Shred it has been hired to do shredding for the township. <u>The Clerk's Report will be put on file.</u>

<u>Treasurer's Report</u> –Karen's hours were included. The expenditures for March 2020 were \$54.996.47. Revenue from March was \$94,608.05 and the Balance on hand as March 1, 2020 was \$407,004.81. The expenditures for April 2020 were \$32,376.24. Revenue from April \$9,796.25 and the Balance on hand as of May1, 2020 was \$446,575.36. Karen reported that she will be moving money into savings accounts at this time due to low interest rates on CD's that are available. <u>The Treasurer's Report will be put on file.</u>

<u>Supervisor's Report</u> – Roger Wickerham presented the Supervisor's report and hours for the month of March and April. In the March meeting, it was stated that we have currently spent \$72,981.00 for zoning since its inception. The following is a breakdown of this cost:

Lawsuit \$39,473 (\$32,700 legal and \$6,773 FOIA)

Start - up Costs \$20,800. (\$16,800.00 legal and \$4,000.00 Administrative)
Actual Zoning Activities \$10,100 (\$8,800 legal and \$4,000.00 Administrative minus \$2,750 fees)
Waived fees that were paid to the County were approx. \$2,000.00

<u>Assessor's Report</u> - There was two new building permits over the past two months, no new foreclosures and one mortgage company sales. <u>The Assessor's report will be put on file.</u>

<u>Planning and Zoning Report:</u> The report from the zoning administrator was included in our packet. The enforcement complaints were discussed. It was noted that at this time we do not have any blight ordinances nor an officer to enforce any complaints. If you have any questions please see Roger.
