Jeana reported that we have currently spent \$94,315.95 for Zoning since its inception. Chris moved to pay the bill as presented, Steve supported.

Roll call vote: Karen Miller - yes, Roger Wickerham - yes, Steve Davidson - yes. Chris Tennes-yes, Jeana Rohrs - yes, Motion carried 5 ayes; 0 nays.

<u>Clerk's Report</u> – The clerk's report was included in the packet. The state provided Covid funds to pay for PPE supplies for Election Day. The Test Decks were run and the Public Accuracy test is scheduled for July 14, 2020 at 6:00 PM. There was a letter sent by my opponent in the race for clerk that had false statements in; I spoke with my opponent and he could not afford to send out more letters but said that he would work on writing a retraction for the Face book page What's Happening in Benton Township; which I have not seen yet. To my disappointment our Supervisor has given a statement of support to my opponent in his letter. Are we as a Charter able to legally vote on contracts and resolution without the correct number of members on the board? Do we need police protection and what are we to do with all of the complaints that we have been receiving that are currently not addressed in our Interim Zoning Ordinance? <u>The Clerk's Report will be put on file</u>.

<u>Treasurer's Report</u> –Karen's hours were included. The expenditures for June 2020 were \$26,744.71. Revenue from June was \$11,278.75 and the Balance on hand as July 1, 2020 was \$379,701.97. . <u>The Treasurer's Report will be put on file.</u>

Supervisor's Report – Roger Wickerham presented the Supervisor's report and hours for the month of June. Roger reported that the well at the cemetery needs to be re-drilled. He has gotten the permit from the Health Department; however there was a delay in digging the well as Johnson Well Drilling Company had some personal issues that have put them behind. The Planning Committee is working on an updated zoning map for the township. MTA is going to file an Amicus Brief with the Court of Appeals for our litigation with Sandstone Creek. The Drain commissioner is letting the Munson Drain project July 29, 2020 with a day of review of apportionments and drainage district boundaries on August 20th. The Supervisor's report will be put on file.

<u>Assessor's Report</u> - There were four new building permits, one new foreclosure and two new mortgage company sales. <u>The Assessor's report will be put on file.</u>
